**PERFORMANCE BOND**

KNOW ALL MEN BY THESE PRESENTS:

That We,

of the State of \_\_\_\_\_ and authorized to do business in the Commonwealth of Pennsylvania, as Surety, are held and firmly bound unto the Susquehanna Area Regional Airport Authority, Dauphin County, Pennsylvania, as Obligee, in the full and just sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_) lawful money of the United States of America, for the payment of which sum, well and truly to be made, we bind ourselves, our heirs, executors, administrators, successors and assigns, jointly and severally, firmly by these presents.

THE CONDITIONS OF THIS OBLIGATION are such that

WHEREAS, THE Principal contemplates entering into a certain Contract with the Obligee to janitorial services at Harrisburg International Airport pursuant to SARAA General Terms & Conditions, the Scope of Work, and Specifications as defined in the Invitation to Bid, attached hereto, which constitute the Contract Documents.

WHEREAS, this Bond is given pursuant to the provisions of the Public Works Contractors' Bond Law of 1967, Act No. 385 of the 1967 General Assembly of the Commonwealth of Pennsylvania.

NOW, THEREFORE, if the Principal and Obligee shall enter into an Agreement with respect to performance of such work, and if the Principal shall promptly make payment to all persons, firms, Sub-contractors, associations, partnerships and corporations furnishing materials for or performing labor in prosecution of the work provided for in the Contract Documents during the term thereof, then this obligation shall be void; otherwise to remain in full force and effect.

The obligation of the Surety hereunder shall extend to all indebtedness incurred by the Principal in connection with warranty and/or maintenance obligation of the Principal, which survive the completion of the work. If the Principal is a foreign corporation (incorporated under any laws other than those of the Commonwealth of Pennsylvania), then further terms and conditions of this Bond are and shall be that the Principal files with the Obligee a certificate from the Pennsylvania Department of Revenue, evidencing the payment in full of all bonus taxes, penalties and interest, and a certificate from the Bureau of Employment and Unemployment Compensation, contribution, penalties and interest due the Commonwealth from said Principal or any foreign corporation, subcontractor thereunder or for which liability has accrued but the time for payment has not arrived, all in accordance with provisions of the Act of June 10, 1947, of the Commonwealth of Pennsylvania.

PROVIDED, FURTHER, the said Surety, for value received, hereby agrees no change, extension of time, alteration or addition to the terms of the Contract or to the work to be performed thereunder or the specifications accompanying the same shall in any way affect the obligation of the Surety on this Bond, and the Surety does hereby waive notice of any such change, extension of time, alteration or addition to the terms of the Contract or to the work or to the specifications.
